



At a Glance: Visa for the Recognition of Foreign Vocational Qualifications

Visa and entry procedure for immigrants from third countries subject to visa obligation. General entitlement requirements (Section 5 of the Residence Act [AufenthG]): passport, proof of financial means, no existing reason for expulsion.

CHECK THE REQUIREMENTS

Step

1

- Proof of German language skills: at least level A2 (CEFR).
 - Secure financing: A remuneration of at least **€941** net / **€1,200** gross per month (for company-based measures) or **€1,091** net per month through a blocked account or declaration of commitment (for school-based measures) is required (as of 2026).
 - **Entry for the participation in qualification measures:** recognition notice indicating the differences that were determined during the recognition procedure **and** permission for suitable measures for qualification or further education in Germany.
 - **Entry for taking an examination:** recognition notice indicating the necessity of taking one or multiple examinations.
 - **Entry for a qualification analysis:** a necessity for a qualification analysis has been determined and confirmation for the qualification analysis is present.
- i Please consider:** in case of a predominantly in-company qualification analysis, the approval of the Federal Employment Agency (BA) is generally requested during the visa procedure.

MAKE AN APPOINTMENT AT THE GERMAN EMBASSY

- Prepare the required documents: e.g. passport, proof of financing, proof of German language skills, visa application form; if necessary: recognition notice, registration confirmation for further training, "Erklärung zum Beschäftigungsverhältnis" (Declaration of Employment) form filled out by the employer (including the recognition annex).
- i Please consider:** on their websites, the German embassies and consulates provide information about possible waiting times for appointments and any additional documents that may be required.

APPLY FOR A VISA IN THE COUNTRY OF RESIDENCE

- Bring the original documents in their entirety.
 - Pay the visa fees: €75 (in local currency).
- i Please consider:** processing times may strongly vary depending on the mission abroad and processing workload. Please find further information on the website of the competent embassy.

ENTER GERMANY

- Issuance of the entry visa for the purpose of the recognition of foreign vocational qualifications.
 - Book flight / plan journey to Germany.
- i Please consider:** in order for an entry visa to be issued, proof of valid health insurance coverage must be presented. After entering Germany, new health insurance must be taken out.

APPLY FOR A RESIDENCE PERMIT IN GERMANY

- Register your home address in Germany at the Residents' Registration Office.
 - Book an appointment at the competent foreigners authority.
 - Ask the foreigners authority for a list of the required documents and start the preparation.
 - In case of **entry for the participation in qualification measures:** apply for residence permit for the purpose of the recognition of foreign vocational qualifications (Section 16d (1) of the Residence Act [AufenthG]). After a **successful qualification analysis** or **positive examination results** concerning full recognition: residence permit for seeking employment or for taking up employment possible.
 - Fees may add up to €100 (Sections 45 ff. of the Residence Ordinance [AufenthV]).
- i Please consider:** the application for the residence permit must be submitted before the entry visa expires.

This overview is a simplified representation of the visa procedure. The steps described are solely for the purpose of clarifying the application procedure for residence permits.
